ABOUT YOUR DONATIONS

Financial contributions to the club qualify for the Colorado Child Care Tax Credit. This allows for a 50% reduction in the after-tax cost of your gift.



TAX SAVINGS GUIDELINES

The maximum credit you may take in any one year is \$100,000 or your actual Colorado income tax liability for the year, whichever is less. Any unused credit may be carried forward for up to five tax years.

Tax Savings Example					
Contribution	\$250	\$500	\$1,250	\$2,500	\$5,000
Colorado Child Care Contribution Credit (50%)	\$125	\$250	\$625	\$1,250	\$2,500
Colorado Tax Savings	\$6	\$12	\$29	\$58	\$116
Federal Tax Savings	\$30	\$60	\$150	\$300	\$600
AFTER TAX COST OF DONATION	\$89	\$178	\$446	\$892	\$1,784

In-kind gifts, such as stock or other securities, labor, or equipment, are NOT eligible - only monetary donations. In the case of donations to the BGCSLV for such things as the Youth of the Year Breakfast or charitable auctions, the portion of your payment eligible for the Credit will be reduced by the value of goods and services you received.

As required by law, BGCSLV will provide each donor with a form stating the amount of the monetary contribution eligible for the Credit and the eligible purpose for which the contribution will be used. The form must be filed with your Colorado State Tax Return.
