The Club is the fiscal agent for two sponsored projects, projects that are consistent with the goals of the Club. The administration of the projects, including the disbursement of funds, is detailed in a written agreement and subject to the review and approval of Club management.

The Club maintains funds which comprise an endowment (the endowment), and, as required by generally accepted accounting principles, net assets associated with endowment funds are classified and reported based on the existence or absence of donor-imposed restrictions. Through 2019, the Club classified as net assets with donor restrictions, to be held for

perpetuity, the original value of gifts donated to the permanent endowment as well as accumulated earnings on those funds. Per the Club's policy, once the fund reached \$1 million, investment earnings could be appropriated for general operations.

During 2020, and due primarily to an absence of written gift agreements and a formal written endowment policy, the Board reached out to the principal donor of the endowment to clarify the intent of the gift and document restrictions, if any, related to the gifts. Based on these communications, the Board of Directors approved an endowment policy in compliance with the Uniform Prudent Management of Institutional Funds Act (UPMIFA) as stated in Colorado Revised Statutes 15-1-1101 through 1110, as well as all other applicable state and federal laws. In accordance with the Club's interpretation of UPMIFA, any remaining portion of the donor restricted endowment fund that is not classified as net assets to be held for perpetuity is classified as net assets with donor restrictions until those amounts are appropriated for expenditure by the Organization in a manner consistent with the donor's intent as stated in the gift instrument. Changes in endowment assets of the Club included a reclassification of accumulated earnings in the amount of \$150,785 as of December 31, 2019, to donor-restricted for time.
